



## PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that the City of Lathrop encourages residents to [apply](#) for positions on City Boards, Commissions and Committees that will have vacancies in 2025. To be eligible for appointment as a member of most bodies, one must be a resident of Lathrop. No officer or employee of the City of Lathrop may serve on a commission, except for the Youth Advisory Commission. Regulations for subject bodies vary (Lathrop Municipal Code Title 2, Chapters 2.12, 2.16, 2.20, 2.24 and Title 3, Chapter 3.13.180). At the end of each year, the City publishes a list of expiring appointed terms for the coming year, names of incumbents, and dates of their appointment, in accordance with Government Code Section 54972.
