#### **CDBG-CV3 Funding Allocation – COVID-19**

- Federal CARES Act 3/27/2020
  - \$5 billion to HUD for CDBG-CV program
  - HUD Allocated CDBG-CV Funding in Phases
    - Phase One: City of Lathrop = \$56,346; and,
    - Phase Two: City of Lathrop = NONE
    - Phase Three: City of Lathrop = \$61,610

Emergency General Assistance Grant Program

5/11/2020 – Council Authorized Emergency General Assistance Grant Program CDBG-CV

- Program designed to aid qualified low-income residents financially impacted by COVID-19.
- Eligible expenses: Past Due Rent/Mortgage and/or Essential Utilities

## Emergency General Assistance Grant Program (continued)

"One-time or short-term emergency payments on behalf of individuals or families, generally for the purpose of preventing homelessness. Examples include utility payments to prevent cutoff of service, and rent/mortgage payments to prevent eviction."

CDBG Federal Statute: Subsistence Payments 24 CFR 570.207(b)(4) or 42 USC 5305(a)(8) + 24 CFR 570.482(c)(2)

# Emergency General Assistance Grant Program (continued)

### City of Lathrop Allocation & Program

- EGA1 CARES Act CDBG-CV Allocation = \$57,075
- EGA2 FY 2020/21 undesignated CDBG funds = <u>\$35,721</u>
- Total CDBG-CV Program Funding
- Less Fair Housing\* Request

=(\$ 729)

= \$92,796

• Total Funding for EGA Program

<u>= \$92,067</u>

### City of Lathrop Allocation & Program

- EGA3 CARES Act CDBG-CV3 Allocation
- Total CDBG-CV3 Program Funding
- Less Request\*
  - Fair Housing = (\$ 236)
  - Stockton Food Bank = (\$7,786)
- Total Funding for EGA3 Program

= \$61,610 = **\$61,610** 

= (\$ 8,022) <u>=\$**52,587.30**</u>

# Emergency General Assistance Grant Program (continued)

#### Program Eligibility & Guidelines (partial)

- Grant Amount: Up to \$3,200 per eligible household
- Available to Pay: EGA1 Past due rent and utilities acquired after 03/27/2020
  - EGA2 Past due rent and utilities acquired after 7/1/2020
  - EGA3 Past due rent and utilities acquired after 3/27/2020

Applicant Eligibility:

- 1. Primary residence within City limits
- 2. Income impacted by COVID-19
- 3. Meet HUD User Income Guidelines

*NOTE: Grant awards issued one per household on first-come, first-serve basis until all designated funds are exhausted. Late payments accumulated after 3/27/20 for City utilities will be deducted prior to paying other bills.*
