RECOMMENDATION: Adopt a Resolution Reciting the Fact of the General

Municipal Election held on November 3, 2020, Declaring the Result and Such Other Matters as

Provided by Law

BACKGROUND:

On June 8, 2020, the City Council adopted Resolution No. 20-4726 calling a General Municipal Election for the purpose of electing a Mayor for the full term of two (2) years beginning December 2020 and ending December 2022; and two (2) Members of the City Council for the full term of four (4) years beginning December 2020 and ending December 2024.

The City Council also adopted Resolution No. 20-4727 requesting the San Joaquin County Registrar of Voters to conduct a Consolidated General Municipal Election on behalf of the City, along with the Statewide General Election to be held on the date pursuant to § 10403 of the Elections Code, November 3, 2020. The election was held with one nominee for City of Lathrop Mayor: Sonny Dhaliwal; and four nominees for City of Lathrop City Council: Jennifer Torres-O'Callaghan, Christopher Lee Sandoval, Rajkanwal Nagra, and Minnie "Cotton" Diallo.

California Elections Code Section 10262(b) provides that in consolidated elections, upon receipt of the results following the canvass of the returns, the City elections official shall certify the results to the governing body no later than the next regularly scheduled City Council meeting or at a special meeting called for this purpose. The San Joaquin County Registrar of Voters provided the results of the canvass of the election on December 3, 2020, to the City Elections Official/City Clerk. The vote counts are as follows:

RESOLUTION NO. 20-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LATHROP CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 3, 2020, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Lathrop, California, on Tuesday, November 3, 2020, as required by law; and

WHEREAS, notice of election was given in time, form, and manner as provided by law; voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the San Joaquin County Registrar of Voters Office canvassed the returns of the election and has certified the results to this City Council, the results were received on December 3, 2020, attached, and made a part hereof as "Exhibit A"; and

WHEREAS, the City Clerk as the City's Election Official has certified the results of the election to the City Council, pursuant to Elections Code Section 10262, attached, and made a part hereof as "Exhibit B".

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Lathrop, California, does hereby resolve, declare, determine, and order as follows:

- Section 1. The number of register voters in the City of Lathrop was 12,807, and the whole number of votes (ballots) cast in the City was 10,250.
- Section 2. That the names of person voted for at the election for Mayor are is follows:

Sonny Dhaliwal

That the names of the persons voted for at the election for Member of the City Council are as follows:

Jennifer Torres-O'Callaghan Christopher Lee Sandoval Rajkanwal Nagra Minnie "Cotton" Diallo

- Section 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates as listed in "Exhibit A" attached.
- Section 4. The City Council does declare and determine that Sonny Dhaliwal was elected as Mayor for the full term of two years; Jennifer Torres-O'Callaghan was elected as Member of the City Council for the full term of four years; and Minnie "Cotton" Diallo was elected as Member of the City Council for the full term of four years.
- Section 5. The City Clerk shall enter on the records of the City Council of the City a statement of the result of the election, showing: (1) the whole number of votes (ballots) cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; and (5) the total number of votes given to each person. Said information is set forth in this Resolution and the documentation attached hereto by reference.
- Section 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.
- Section 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
