## City Council Meeting September 12, 2022 Item 5.5



- On August 9, 2022, the City Council directed Staff to research Tattoo/Body Art Establishments permitting requirements in surrounding jurisdictions.
- Tattoo/Body Art Establishments are currently not listed as a use in the Lathrop Municipal Code (LMC).
- "Tattoo/Body Art Establishments" means businesses providing the following services:
  - Tattooing; and
  - Body Piercing.

- Permit Tattoo/Body Art Establishments by-right in Commercial Zoning Districts.
- Require a Conditional Use Permit in Commercial Zoning Districts.
- No change in the LMC (Tattoo/Body Art Establishments not permitted).

Commercial Zoning Districts include Highway Commercial, Central Commercial, Neighborhood Commercial, Service Commercial and Commercial Zoning Districts in River Islands, Central Lathrop, Mossdale, South Lathrop, and Lathrop Gateway.
