Inflation Factor Policy

The annual adjustment for the fees shall be the same percentage change as the general adjustment to employee salaries and benefits approved by the the City Council for the calendar year in which the annual fee update occurs or the actual increase in CPI for Urban Wage Earners and Clerical Workers for the San Francisco/Oakland/San Jose area for the twelve month period concluding wth the October index of each preceding year.

Rounding Policy

The rounding policy is applied in most cases except where departments determine that no changes to fees are necessary or outside agencies control the fee rate. All fees are rounded to the nearest dollar. Numbers that end in 1 through 4 are rounded to the next lower dollar, and numbers that end in 5 through 9 are rounded to the next higher dollar.
