9.2 Neighborhood Design Plan No. NDP-21-29. River Islands Amendment to Lakeside East and West Architectural Design Guidelines and Development Standards (DG/DS)

Commissioner Gatto asked if all architectural features shown on the design guidelines are incorporated in all the villages. Ramon Batista of River Islands replied that builders use the examples as a guide but have the option to choose the various architectural elements for their projects.

Vice Chair Dresser asked if the proposed reduction of setbacks from three feet to two feet complies with fire code. Mr. Niskanen explained that the reduction pertains to is only allow architectural projections within the two-foot setback.

Vice Chair Dresser asked about outfall. Mr. King gave a brief overview of all the work being done in the project. Commissioner Gatto asked if there is a project timeline. Mr. King replied that they anticipate to start within the year.
