8. PUBLIC HEARING ITEMS

8.1 Municipal Code Text Amendment TA-18-56

Mr. Meissner made the staff report presentation.

Commissioner Lazard asked what will happen if the signs are not taken down on time. Mr. Meissner replied that Code enforcement will take care of this.

Mr. Navarrete replied that the revised ordinance will be included as part of the binder to be distributed to political candidates. Chair Torre-O'Callaghan also asked if there will be changes for wrapped signs. Mr. Meissner replied that the amendments does not include vehicular signs when vehicles are used for traveling on roads, etc.

After the 90-day time limit, Chair Torres-O'Callaghan asked if the sign owner will get another 90 days extension if they temporarily remove and return the sign after 24 hours. Mr. Meissner replied that staff will still have to work on a process to address this issue.
