8. PUBLIC HEARING ITEMS

8.1 Municipal Code Text Amendment No. TA-20-71

Mr. Caguiat made the staff report presentation.

Commissioner Rhodes asked if the existing second driveways in the Historic Lathrop Overlay district is subject to the proposed amendment. Mr. Caguiat replied that the section is applicable to new driveways and it also allows for grandfathering of existing driveways.

Regarding Chapter 17.16, Commissioner Rhodes is concerned about the removal of the Fire Code reference on the zoning ordinance. The commissioners wanted to ensure that the public is aware that other code restrictions, such as Fire and Building codes, may apply in conjunction with zoning requirements. A discussion ensued.

Commissioner Rhodes suggested that all departments work together to provide the public with comprehensive information pertinent to their plan.

Mr. Dresser asked if there are changes to public notice postings on closed City facilities due to COVID-19 restrictions. Ms. Vargas replied that there has not been any legislation update on public noticing related to COVID-19. She also stated that notices are posted on the exterior of the facilities for easy public access. Mr. Caguiat added that agendas are posted on the City website and sent to Planning Commission email subscribers.

Mr. Caguiat informed the commission that Staff has received two comment letters from the public for the Planning Commission meeting. However, one letter was not regarding the public hearing item.

Mr. Marty Harris has contacted the City (by email and letter) about his concern on removing "Storage yards for commercial vehicle" as a permitted use in the zoning ordinance. Mr. Meissner contacted Mr. Harris and explained that the proposed changes only applies to Central Lathrop and not Lathrop Gateway. After the clarification, Mr. Harris withdrew his objection.

No other public comments were received, either physically or by teleconference, regarding the item on discussion.
