The Lathrop Police Department provides a free Residential Vacation Check Program for Lathrop Residents. If you are interested in using this service, please follow the instructions below.

Complete the attached form in its entirety and submit your application 3–5 days prior to your vacation. Advanced notice is required for processing and scheduling.

There are three ways to register for Residential Vacation Checks:

1. Download an application and submit it to the LPD Records Department. Please allow extra time (3-5 additional days) if mailing in your request to ensure that it was received before your departure date.
2. You may call the Records Department to submit a request over the phone.
3. You may come to the Lathrop Police Department and fill out a Residential Vacation Check application in person.

Residential Vacation Check Notes:

Please call us immediately @ 209-647-6400 if you return prior to the date listed on the Vacation Check application. Our personnel are not able to differentiate between your early return and an intruder.

Residential Vacation Checks are performed Monday through Friday. Applications **must** be received before the vacation start date.

Vacation Checks are generally limited to 30 days. Due to the high volume of requests, there is no guarantee that requests over 30 days will be checked multiple times a week.

Backyards with broken, sticky, or difficult to open gates will not be checked.

At this time, Lathrop Police vacation check services only extends to Lathrop residents who are on vacation. We do not patrol vacant homes or provide general security checks for occupied homes.
