

## ADDENDUM NO. 1

### Retaining Wall Landscape Project No. CIP GG 10-17

This addendum amends the Contract Drawings and Specifications for this project as follows:

1. Add the statement below to the Notice to Contractors – GG10-17 after the first paragraph:

“Due to COVID-19 safety precautions and pursuant to the State of California Governor’s Executive Order N-35-20, the following bid submittal protocol has been adopted by the City of Lathrop for Contractors wishing to submit bids in-person.

A Contractor wishing to submit their bid in-person shall bring their sealed bid to the City Council Chambers through the western-most doors to City Hall by **1:50 pm on Thursday, April 2, 2020**. Once inside, Contractor shall drop their bid into the box marked “BIDS FOR GG 10-17” and promptly exit the Council Chambers until 2:00 pm. Bids will be opened in a public forum, but due to social distancing recommendations from the State of California, all contractors will maintain a minimum of 6’ separation from each other at all times. No sign-in sheet will be provided, so each contractor is required to attach a business card with contact information to the outside of their bid package.

The City of Lathrop reminds all bidders to respect social distancing guidelines when inside the City Council Chambers, and thanks you for doing your part to slow the spread of COVID-19 while continuing to conduct business.”

2. ADD the following sentence to the Project Specifications after the the paragraph entitled EXPERIENCE OF BIDDERS on page 00100-5 (*Instructions to Bidders*):

“The appropriate specialty license for this project is C-27, Landscaping.”

3. Replace the Bid Schedule on pages 00300-2 and 00300-3 (*Bid Proposal Forms*) of the Project Specifications with the Revised Bid Schedule in Attachment 1 revised to account for the following changes:

- Bid item #3 “Erosion Control / SWPPP” has been replaced with “Erosion & Sediment Control Plan”.
- ADD bid item #28: “Ground Cover, 1 gal”: 200 ea.

- INCREASE bid item #10 "Mulch @ 3" min. depth" from 15,000 SF to 22,000SF
- INCREASE bid item #14 "Irrigation" from 15,000 SF to 22,000SF
- INCREASE bid item #11 "Decomposed Granite @ min. 2" depth" from 900 SF to 2,400 SF
- DECREASE bid item #20 "3/4"-1" Tan Decorative Aggregate @ min. 2" depth" from 1,000 SF to 600SF.
- CHANGE bid item #12 "30" – 48" Boulders" 1 TON to: "30" – 48" Boulders, 23 EA"

4. ADD the following Subsection A-18 – *Landscape General* to the Project Specifications, in Section 02000 *GENERAL TECHNICAL* after Subsection A-17 *Watering*:

**A-18 Landscape General**

Boulders: Contractor shall supply and place according to plan:  
 Minimum of 6 boulders of approximately 36" diameter  
 Minimum of 6 boulders of approximately 40" diameter  
 Minimum of 6 boulders of approximately 48" diameter

When submitting the bid for the project, the Contractor must acknowledge receipt of the addendum.
